



TOWN OF BOONSBORO, MARYLAND REQUEST FOR PROPOSAL 2019 MOWING SERVICES

I. PROJECT OVERVIEW

The Mayor and Council of Boonsboro, Maryland, is requesting proposals from qualified contractors to provide mowing services of several properties owned by the Town of Boonsboro.

II. SCOPE OF WORK

The scope of work consists of providing all labor, materials, equipment, and incidentals for the weekly mowing and trimming of several Town-owned property parcels during the 2019 mowing season from April through November. The contract may be extended for two additional one-year terms, as approved by the Mayor and Council.

A listing of the parcels with an approximate location is provided within this Request, although a site visit is recommended to determine actual parcel size.

III. SUBMITTAL FORMAT AND CONTENT REQUIREMENTS

One (1) Copy of the proposal shall be submitted and include the following criteria;

1. Contractor/Company Qualifications
2. Statement of Experience- A detailed narrative may be included in addition to the required Statement (Attachment A)
3. Property Listing Bid Form (Attachment B)
4. Proposed Mowing Schedule

IV. INSURANCE AND LICENSING

The following insurance and licensing documents will be required and maintained during the period of the contract. Copies must be presented at the time of signing of the contract.

- A. Statutory Worker's Compensation Insurance.
- B. Public Liability and Property Damage Insurance – Minimum \$1,000,000 per occurrence to protect contractor and town from claims for damages for personal injury, accidental death, and damage to property
- C. Certificate of Liability Insurance naming the Town of Boonsboro as the additional insured for all work performed by the contractor insured during the mowing contract period.

V. INQUIRIES AND RECEIPT OF BID PROPOSALS

Bids: Bids must be received by the Town of Boonsboro, either by mail or hand delivery, no later than **10:00 AM** local time on **Wednesday, March 13, 2019** in a Sealed Envelope marked "**Mowing Service Proposal**" at the following address:

Any Bids received after the above time will not be accepted under any circumstances. Any uncertainty regarding the time a Bid is received will be resolved against the Bidder.

Opening and Reading: The Bids will be publicly opened and read aloud at 10:05 AM on Wednesday, March 13, 2019 in the Town Hall located at 21 North Main Street, Boonsboro, Maryland.

Pre-bid Conference: A pre-bid conference will not be required. Contractors may contact Public Works Superintendent Greg Huntsberry at 301-992-3714 to schedule a site visit of the property parcels to assist with bid preparation.

Award, Waiver and Rejection of Bids: Bid proposals will be presented to the Mayor and Council of Boonsboro for final review and consideration for contract approval. Owner reserves the right:

- a. To reject any or all Bids.
- b. To waive any informality or irregularity in any Bid received.
- c. To accept the Bid deemed by the Town of Boonsboro to be the most advantageous to its interests.
