## INVITATION FOR BIDS

### Boonsboro Milling & Asphalt Overlay: Park Drive, McKeldin Drive, & Center Street

#### I. PROJECT OVERVIEW

The Mayor and Council of Boonsboro, Maryland, is requesting bids from qualified contractors to provide milling and asphalt overlay services for Park Drive, McKeldin Drive, and Center Street.

#### II. SCOPE OF WORK

The project will consist of milling town streets to a depth of 2-inches, where necessary, and installing a 2-inch asphalt overlay. Contractor is responsible for removal/disposal of old materials and shall keep project area clean of debris.

#### III. PROJECT DETAILS

1. Park Drive: Mill/Overlay 3,249 SY of pavement, between Potomac Avenue and the entrance to the North Parking Lot of Shafer Park.
2. McKeldin Drive: Mill/Overlay 1,509 SY of pavement, between Park Drive and Park Lane.
3. Center Street: Mill/Overlay 950 SY of pavement, between St. Paul Street and Lakin Avenue.

Firms submitting bids must be able to complete the project, by December 31<sup>st</sup>, 2020. A pre-bid meeting, for all interested contractors, is scheduled for \_\_\_\_\_ at the Community Center in Shafer Park, 37 Park Drive, Boonsboro, MD 21713.

#### III. SUBMITTAL FORMAT AND CONTENT REQUIREMENTS

One (1) Copy of the bid proposal shall be submitted and include the following criteria:

1. Contractor/Company Qualifications, including licenses/certifications
2. Certificate of Insurance
3. List of References

Any bids received after the above time will not be accepted, under any circumstances. Bids shall remain valid for 90 days.
