**ORDINANCE 2020-09;  
AN ORDINANCE AUTHORIZING  
ENTRY INTO A NON-EXCLUSIVE FRANCHISE AGREEMENT  
WITH COMCAST OF  
CALIFORNIA/MARYLAND/PENNSYLVANIA/VIRGINIA/WEST VIRGINIA, LLC**

**RECITALS**

WHEREAS, by virtue of State Laws and the Charter of the Town of Boonsboro, the Town of Boonsboro has the authority to grant exclusive or non-exclusive franchises, to impose franchise fees, and to establish rates, rules, and regulations for franchises granted under applicable law; and

WHEREAS, the Mayor and Council desire to enter into a non-exclusive franchise agreement with Comcast of California/Maryland/Pennsylvania/Virginia/West Virginia, LLC ("Comcast"); and

WHEREAS, the Mayor and Council now deem it in the best interest of the citizens of Boonsboro to enter into a non-exclusive franchise agreement with Comcast.

**NOW, THEREFORE, BE IT RESOLVED, ENACTED AND ORDAINED** by the Mayor and Council of the Town of Boonsboro, Maryland, as its duly constituted legislative body, as follows:

SECTION 1: The foregoing recitals be and are incorporated herein as if restated verbatim.

SECTION 2: That the Town of Boonsboro be and is hereby authorized to execute and deliver the Cable Franchise Agreement Between Town of Boonsboro, Maryland and Comcast of California/Maryland/Pennsylvania/Virginia/West Virginia, LLC attached hereto and incorporated herein, and to execute any additional documentation required to effectuate the purposes of this Ordinance.


SECTION 3. Effective Date. This Ordinance shall become effective immediately upon the effective date of this Enacting Ordinance.


